The Stakeholders Relationship Committee (SRC) of Board of Directors of the Company has *vide* Circular Resolution dated November 22, 2023 approved the allotment of 71,949 Equity Shares of Rs.5/- each on November 23, 2023 at 4:19 P.M. to the option grantees who have exercised their options granted under the ESOP Schemes detailed hereunder:

- 33,425 Equity Shares under the Intellect Stock Option Plan 2015 (ISOP 2015) Scheme
- 3,600 Equity Shares under the Intellect Stock Option Plan 2016 (ISOP 2016) Scheme
