#### More time needed

The WHO explained that vaccine manufacturers required time to scale and optimise their production processes in the early phases of the vaccine roll-out. AstraZeneca, which uses a novel supply chain network with sites across multiple continents, is working to enable initial supply to 82 countries through COVAX in the coming weeks.

COVAX expects to supply initial doses of vaccines to all participating economies in the first half of the year before ramping up significantly in the second half of 2021, it said, adding that vaccines had been shipped to over 50 countries and economies.

## Sunil Mittal-led OneWeb launches 36 new satellites

Mumbai, March 26

Sunil Mittal-led low-earth orbit (LEO) broadband satellite communications company OneWeb has successfully launched 36 satellites. This launch, the second after a con-segrium led by Mittal took ownership of the UK satellite company, brings its total in-orbit constellation to 146 satellites. These will form part of OneWeb's 648 LEO satellite fleet that will deliver high-speed, low-latency global connectivity.

This is the second in a five-launch programme that will enable OneWeb's connectivity solution to reach all regions north of 50 degrees latitude by the middle of 2021, with service ready to start by year's end, giving OneWeb the ability to connect millions of consumers in the northern hemisphere.
