**Sub: Allotment of Equity Shares under Associate (Employees) Stock Option Plan (ASOP)**

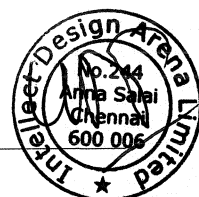
